RE: Parking Changes on 1st St SE, L St SE, and Cushing Place SE

Dear Director Marootian:

At a regularly scheduled and properly noticed public meeting on June 10, 2019, with a quorum being present, a quorum being 4 Commissioners, Advisory Neighborhood Commission (ANC) 6D voted 7-0-0 in support of various changes to parking on 1st St SE, L St SE, and Cushing Place SE, as well as installation of additional signage and crosswalk identification in the vicinity.

The ANC's primary concern is ensuring the safety of residents, motorists and bicyclists as well as the ability of residents to enjoy their neighborhood and to move about freely. The ANC is particularly concerned about resident safety when crossing neighborhood streets near their homes and about the clear delineation and enforcement of no-parking areas.

Pursuant to DC Code § 18-2405.2(d) (2017), parking or standing a motor vehicle within 25 feet of the approach side of a stop sign is prohibited, except to avoid conflict with other traffic, to obey the direction of a police officer, or to momentarily stop to discharge or load passengers.

Accordingly, the ANC, with the support of the Board of the Velocity condominium building at the intersection of 1^{st} St Se and L St SE, requests the following changes:

1. Designation of a 45-foot no-parking zone on the west side of 1st Street SE, immediately north of the 1st & L Street SE intersection. This would create the 25-foot no-parking zone contemplated by section 18-2405.2(d) with the loading zone terminating at the start of the tree box;

- 2. Designation of a 36-foot no-parking zone on the north side of L Street SE, west of the 1st and L Street SE intersection. This would create the 25-foot no-parking zone contemplated by section 18-2405.2(d) with the loading zone terminating at the start of the tree box;
- 3. Designation of a 25-foot no-parking area on the east side of Cushing Crosswalk along the north side of L Street SE (where Cushing Place runs into L St SE); and
- 4. Designation of a 38-foot parking buffer on the east side of Cushing Crosswalk along the south side of L Street SE (where Cushing Place runs into L St SE).

In addition, in keeping with the ANC's focus on resident safety and well-being, we request that DDOT install the following safety measures in the vicinity:

- 5. Placement of pedestrian crossing signs on both sides of the light post on the north side of Cushing Crosswalk at the intersection of L St and Cushing Place SE;
- 6. Installation of flashing crosswalk lights and an elevated crosswalk on the Cushing Crosswalk at the intersection of L St and Cushing Place SE;
- 7. Installation of flashing crosswalk lights and an elevated crosswalk on the crosswalks at 1^{st} St and L St SE; and
- 8. Installation of stop signs on the opposing traffic lane dividers on 1st Street SE.
